Requirements

VIEWING

You can view the facility by taking our virtual tour at www.ceres.gov and select the Recreation icon.

DEPOSIT

Damage/cleaning deposit of \$600 must be paid at the time of reservation.

Refunds can take up to 8 weeks after your event to process. Any charges for damage, loss or excessive cleaning will be deducted from the deposit.

CANCELLATIONS

- 6-12 months in advance 10% of deposit is kept.
- 3-6 month in advance 25% of deposit is kept.
- 1-3 month/s in advance 50% of deposit is kept.
- Less than 30 days in advance 100% of deposit is kept.

Reservations can be made up to 13 months in advance.

Additional Information

INSURANCE

- An insurance policy of one million dollars (\$1,000,000) will be required to rent the facility.
- Special event insurance must be obtained 30 days before your event.
- Please note that the name on the certificate and the renter must match.

SECURITY

Security must be booked by the renter using our approved security company list.

Security needs:

- With Alcohol: 2 guards
- No Alcohol/60+ people: 2 guards
- No alcohol/less than 60 people: 1 guard

Key must be picked up at the Ceres Community Center at the start of rental time.

Staff will let you know security hours at the time of booking.

EQUIPMENT

- Renter is responsible for setup and teardown of facility.
- Tables and chairs are available for use.
- The renter assumes all responsibility for any damage resulting from the use of the equipment.
- The property and equipment within the building are not to be removed from the premises.

KITCHEN

The use of the warming kitchen stoves is for re-heating and serving of previously cooked food.

ALCOHOL

- If serving alcohol, a bartender is mandatory. Person serving cannot be a guest of event.
- No glass bottles allowed outside of bar.
