City staff will make every effort to address all known issues at this stage. However, as your project evolves or as additional information becomes available, further issues, requirements, or recommendations may be identified.

To ensure more specific and useful feedback, we encourage you to submit as much detailed information as possible with your application. The more comprehensive your submittal, the more targeted and helpful our preliminary comments can be.

Pre-application meetings are held by appointment only on the 1st and 3rd Thursdays of each month. To schedule a meeting with the pre-application committee, please submit the following electronically to [planning@ceres.gov](mailto:planning@ceres.gov):

- A written project description or operational statement
- A conceptual site plan

Meetings will be scheduled approximately **1.5 to 2 weeks** after we receive your pre-application materials, to allow City staff sufficient time for review and to prepare high-level comments.
