Traffic Advisory;

The purpose of this letter is to inform you that Garney Construction, in partnership with the City of Ceres, will begin work on water main connections at Mitchell & Hatch Road intersection. The work will be performed during night hours from **8:00 PM through 5:00 AM**. Message board signs are placed in various locations alerting commuters in advance of street closure. The project will effect some traffic delays due to lane shifting and lane closures during construction. Detour signs will be posted each night and taken down every morning. 
