General Information

- Book up to 13 months in advance in person or online.
- Rentals may be rescheduled once up to 7 days before your rental.
- All park rentals begin at sunrise and end at sunset/dusk.
- No alcohol is allowed at City parks.
- Amplified sound is NOT permitted within City parks.
- No vehicles are allowed on the grounds and any damages are the responsibility of the renter.
- Ceres Municipal Code: Title 9, Chapter 16

Cancellation Policy

Forfeited percentage based on days prior to cancellation:

- 3 - 12 months – 25%
- 1 to 3 months – 50%
- Less than 30 days – 100%

Indemnity/Hold Harmless Agreement: Undersigned shall indemnify, defend, and hold harmless the City, its officers, employees, agents and volunteers ("City indemnitees"), from and against any and all causes of action, claims, liabilities, obligations, judgments, or damages, including reasonable legal counsels' fees and cost of litigation ("claims"), arising out of the Undersigned's performance of its obligations under this agreement or out of the operations conducted by Undersigned, except for such loss or damage arising from the sole negligence or willful misconduct of the City. In the event the City indemnitees are made a party to any lawsuit, or other adversarial proceeding arising from Undersigned's performance of this agreement, the Undersigned shall provide a defense to the City indemnitees, or at the City's option, reimburse the City indemnitees their costs of defense, including reasonable legal counsels' fees, incurred in defense of such claims.

Bounce House - Undersigned agrees that the use of a Bounce House or other inflatable apparatus at the above named park is to be used by those invited to the party ONLY. Undersigned also agrees to be responsible and assume all risks associated with the use of the Bounce House or other inflatable apparatus and will not hold the City of Ceres liable. Undersigned also agrees to supply their own generated power for the Bounce House or other inflatable apparatus.

Please Note: Renters MUST provide adult supervision at all times.

Assumption of the Risk and Waiver of Liability Relating to COVID-19 -

By signing this agreement, I acknowledge the contagious nature of COVID-19 and other communicable diseases and voluntarily assume the risk that I may be exposed to, or infected by COVID-19 by participating in the above picnic area rental, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the above picnic area rental may result from the actions, omissions, or negligence of myself and others, including, but not limited to, City of Ceres employees, volunteers, park goers and members of the public.
