

CONSTRUCTION & TRAFFIC ADVISORY

THE CITY OF CERES WILL BEGIN PAVEMENT PRESERVATION AND ADA CURB RAMP UPGRADES ON SEVERAL STREETS STARTING SEPTEMBER 15, 2025, WITH WORK CONTINUING THROUGH DECEMBER 2025. IMPROVEMENTS WILL INCLUDE SLURRY SEAL, CAPE SEAL, STRIPING, AND ADA CURB RAMP UPGRADES TO IMPROVE ROADWAY SAFETY, ACCESSIBILITY, AND EXTEND PAVEMENT LIFE.

AFFECTED STREETS INCLUDE:

- SITE AREA 1: LUCCHESI LN, VLACH WY, GREENBACK LN, CLING CT, LARMUSEAL LN, WESLEY DR, ALWAY DR, FOSTER DR, CADILLAC DR, CULLEN AVE, COGNAC WAY, LARSEN DR, WINEPRESS LN, VERDEA CT, WOODWORTH AVE, MUSICK AVE, HERNDON RD, RICHLAND AVE
- SITE AREA 2: CANYON DR, LEHI AVE, MOUNTAIN RIDGE DR, WALTER DR, PINE RIDGE DR, GROVERR DR, FRUIT RIDGE CT, FLAT RIDGE CT, LANDER CT, OAK RIDGE DR, ROCKY RIDGE CT, OAKRIDGE CT, MOFFETT RD, HATCH RD
- SITE AREA 3: DON PEDRO RD, DAISY TREE LN, RED HAVEN LN, BUCKTHORN LN, ALMOND GROVE LN, DANO CT

WHAT TO EXPECT:

- TEMPORARY LANE CLOSURES AND PARKING RESTRICTIONS IN WORK AREAS
- CONSTRUCTION ACTIVITY AND EQUIPMENT IN NEIGHBORHOODS
- ACCESS TO HOMES AND BUSINESSES WILL REMAIN OPEN, BUT MINOR DELAYS ARE POSSIBLE

PROJECT TIMELINE:

- 17 SEPTEMBER 15 – DECEMBER 2025 (WEATHER PERMITTING)
- WORK HOURS WILL GENERALLY BE DAYTIME TO REDUCE DISRUPTION
